Due to proposed Maryland budgetary constraints that are beyond the control of the Carroll County 4-H & FFA Fair Board, Inc. The Board reserves the right to withhold a portion of premium monies, up to and including all of an exhibitor's earned premium payment, for the Carroll County 4-H & FFA Fair.

- Exhibitors must be enrolled in a beef project or veterinary science project to participate in the Beef Cattle Department at the Fair.
- Exhibitors must submit a signed Maryland Show Ring Code of Ethics with entry form.
- Youth with market livestock must submit a Livestock Feed Assurance Certificate with entry form.
- Your original approved Animal Health paper must be available for review prior to unloading your animal(s) at the Fair. Certificates of Veterinary Inspection & Self Certification sheets may be found at [www.mda.state.md.us](http://www.mda.state.md.us) for your updated information website.

**RULES AND REGULATIONS – Beef Cattle Department**

1. All 4-H and FFA members must abide by the General Rules and Regulations of the Carroll Co. 4-H & FFA Fair as printed in the beginning of this Fair Catalog.
2. Beef market steers and market heifers must be owned by January 1 of the current year.
3. Steers and market heifers must be identified (tagged) in accordance with the statewide uniform Market Livestock Tagging system.
4. All Projects ARE Required by the Maryland Department of Agriculture to have a RFID tag (Radio Frequency Identification Tag) in your Beef project ear at tagging and weigh-in. The Silver /White metal tags are no longer accepted. The MDA Website: [http://mda.maryland.gov/Animal Health/Pages/default.aspx](http://mda.maryland.gov/Animal%20Health/Pages/default.aspx)
5. The Committee may visit all beef animals at the place of which the animal is being housed between the tagging date and the Carroll County 4-H & FFA Fair.

6. If the Committee feels there is a problem with any of the animals being exhibited in the purebred class, they will notify the exhibitor. The Committee may go to the member's residence at a later date to review the questionable animal with a representative of the breed association. The Breed Association representative will decide if the animal should be shown as a purebred or a crossbred. The exhibitor may then:
  - a. Accept the decision of the Breed Association representative, making the decision final.
  - b. The Beef Committee may request testing and the Fair Board will support the Committee decision.
  - c. If any protest is raised concerning an animal, the protestor will bear all expenses of testing unless the test is found to be positive in which the animal's owner will reimburse the protestor.
  - d. If scurs appear on an animal exhibited as an Angus at the Fair weigh-in, this animal must be shown in the Crossbred division.
7. All steers and market heifers to be shown as purebred MUST have registration papers to verify breed and also MUST be registered in the 4-H or FFA member's name.
8. All purebred steers and market heifers must have a legible tattoo prior to arriving at the fair for weigh-in. Illegible tattoos or if no tattoo is found, the steer or market heifer will be moved to the crossbred division regardless. No tattooing on the fairgrounds.
9. The Beef Committee shall have the right to disqualify a beef animal with a health problem. If any question shall arise, the state veterinarian will be consulted.
10. Bedding in the barn will be provided and is included in the \$10 entry fee for market animals and \$3 for breeding animals. Bedding must be removed at the direction of the superintendent.
11. Stall assignments will be posted and strictly adhered to. Any requests to move must be approved by the beef committee chairman. Stall Assignments are used to find exhibitors on show and sale day, in case of an emergency for a Veterinarian, or if a Superintendent needs to find an exhibitor or an animal.
12. A Beef Committee member must be present during individual stall setup. A schedule will be announced for setup dates and times.
13. Stall dividers will be allowed. Dividers are to be no more than 4" wide and no longer than 8 feet. One stall per animal shown at the Fair.
14. All fans will be placed in accordance with directives by the Beef Committee to assure safety and adequate airflow within the beef cattle exhibit area.
15. All aisle ways must be kept clean at all times.
16. Animals must be off of tie-outs by 8am each day of the fair.
17. Blocking chutes are to be set up in designated areas only.
18. No outside scales will be allowed on the premises. Only the official scale.
19. No enclosed tents are allowed on the fairgrounds. Pop-up tents are allowed in designated areas outside of the barn, for shade, but the inside of the tent must be able to be viewed from all sides.
20. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified. Any exhibitor with an uncontrollable animal will be given a 24-hour grace

period to prove to the Beef Committee that their animal is controllable and does not pose a safety threat to any/or all exhibitors and the public visiting the Fair.

21. Any exhibitor showing a steer or market heifer may have fitting assistance from an immediate family member (Parents, brother, sister or any Beef Committee member or Carroll County 4-H Member. **NOTE: The key word is assistance.** This project is a learning experience and we want the exhibitor to learn by doing.
22. Fitting rules for Beef Cattle. The use of ANY coloring agent or hair adhesives are PROHIBITED. This means you may NOT use them during the Carroll County 4-H & FFA Fair Beef Shows, unless it is stated in the rules of a specific class or contest.
23. Use of unethical practices are prohibited – fake hair, tail, etc.
24. A Breed Division is defined as Four (4) registered animals of that breed. If there is not a minimum of 4 head entered in any breed division, then the animals will be moved to the (AOB) All Other Breeds Division to be shown.
25. Livestock Exhibitors (beef cattle, sheep, meat goats, and swine) are required to wear the following uniform for all classes:
  - a. Male- Khaki or green trousers – no shorts are permitted. FFA members may wear standard FFA attire. All shirts are to be white, have a collar, and be able to be tucked in. All exhibitors must have a neckpiece (green or black)
  - b. Female-Green, khaki skirt, slacks, or culottes – no shorts are permitted. FFA members may wear standard FFA attire. All shirts are to be white, have a collar, and be able to be tucked in. Shirts may be sleeveless for girls –but no straps or spaghetti-style straps will be permitted. No shirts exposing bare midriff. Sleeveless polo style or button-down shirts are allowed. All exhibitors must have a neckpiece (green or black). NO HATS other than show hats may be worn during the show.
26. Breed Division (within the Heifer or Market Beef categories) may be separated if the Beef Committee decides it is in the show's best interest.
27. All beef exhibitors who wish to sell in the Livestock Sale must comply with the Livestock Sale Rules.
  - a. Market steers and market heifers must have a rate of gain of 2.0 lb. per day to be eligible for the Livestock Sale.
  - b. Market steers and market heifers must meet the Livestock Sale weight requirement for the Carroll County Fair of between 1200 – 1500 pounds.
28. All beef animals not in the livestock sale will be released following the conclusion of the market beef show. All animals that are leaving must be out by 8am on Friday, before the sale.
29. All beef exhibitors are encouraged to attend either the educational workshop at the Beef Field Day or the educational beef workshop presented by the Beef Committee.
30. **(NEW FOR 2024)** Feeds and supplements approved for livestock use may be used by exhibitors. If an exhibitor feels their animal is in need of electrolytes due to the health concerns they may be administered upon the recommendation of a veterinarian, by the veterinarian, and in the presence of the Department Superintendent, the Livestock Area Superintendent or one of the Livestock Area Assistant Superintendents.

**31. (NEW FOR 2024)** When an animal is in need of veterinarian care while on the Fairgrounds the Department Superintendent must be notified. When an animal requires veterinary treatment while at the Fair, you may use the Veterinarian on the grounds at your cost, call your Veterinarian at your cost, or remove your animal from the Fair.

**32. (NEW FOR 2024)** All exhibitors are expected to follow all 4-H and FFA rules, including the Exhibitor Code of Conduct, Animal Ethics and Welfare, General Fair rules, Livestock Sale Committee rules and Department rules for each specific species being exhibited by 4-H and FFA exhibitors.

### **Showmanship – RULES AND REGULATIONS**

1. Exhibitors will compete for showmanship honors in their age divisions. Animals will be washed, blown dry and brushed/combed only.
2. Champions from Senior, Intermediate and Junior divisions will return for the selection of Grand Champion.
3. Once the exhibitor has entered the show ring, they are not permitted to leave for any reason. There will be no help from outside the show ring.
4. All beef exhibitors will be required to exhibit in the Showmanship Division in order to participate in the Market Division.
5. Exhibitors must own the animal presented in the Showmanship Division.
6. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified.
7. Exhibitors must wear proper 4-H or FFA attire, please see rules and regulations number 23.
8. The showmanship animal must be a market animal unless the only beef project the exhibitor owns is a breeding heifer. In that case, the breeding heifer may be shown in showmanship.
9. The Champion of Champions class will consist of previous year's winners. The current champion will not participate.
10. Premium – Showmanship Participation - \$5

### **Individual Beef Fitting Contest – RULES AND REGULATIONS**

1. Animals must be unclipped, washed and blown dry only. The Beef Committee will determine the eligibility of the animal. Please check your Fair Schedule to see when the contest is scheduled.
2. The market beef or breeding heifer (if it is your only project) to be entered in the Individual Beef Fitting Contest must be your own beef project entered at the Carroll County Fair.
3. There will be a 45-minute time limit.
4. These fitting rules apply to the Individual Beef Fitting Contest only. Adhesives may be used during the fitting time allowed. **Absolutely No fake hair or twining.** Absolutely No Colored Show Foam, or Any Other Colored Agents. NO paint may be applied to your animal. Any questions please see the beef Superintendent.

5. Once the exhibitor has started, members are NOT permitted to leave for any reason.
6. The members will be judged on their ability to use clippers and other equipment as well as their technique of fitting, use of adhesives and the overall appearance of the animal.
7. NO OUTSIDE help will be allowed. **NO COACHING from outside the ring.**
8. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified.
9. Champions selected from Senior, Intermediate, and Junior divisions will return for the selection of Grand Champion.
10. All prizes for the Individual Beef Fitting Contest will be determined by the Sponsors of the Contest.

#### **Beef Heifers - RULES AND REGULATIONS**

1. Breeding heifers must be the bona fide property of the exhibitor and must be solely owned and registered in the name of the exhibitor only by June 10th of the current year.
2. The committee will check breed registration certificates and tattoos at Fair arrival. **Entries received, at the fair, with “Papers Pending” will not be accepted.** Registration must be from the certified breed association as a pure breed heifer.
3. An entry fee of \$3 per heifer is payable with the entry form.
4. Commercial Heifers must be owned by June 10th of the current year. They must be tagged and tattooed by the owner and will have a Maryland State identification tag placed in their ear. Tagging may take place at the same time as market steer and market heifer tagging, prior to the Fair. Tag cost is \$2.00. Commercial Heifers will be shown by weight and not by age. Heifers of Other Recognized Breeds MUST have a registration paper to verify ownership of the exhibitor and age of the animal.
5. All heifers, except Commercial Heifers, will be born after September 1, 2022 and born before July 1, 2024. Superintendent may break classes according to age if necessary.
6. All commercial heifers must be of beef origin.
7. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified.
8. Heifers may be shown in this order: Angus, Hereford, Red Angus, Shorthorn, and Registered Purebreds of Other Breeds and Commercial. Or in an order determined by the Beef Superintendent and Committee. Heifers will enter the show ring according to age – youngest heifer first with the exception of commercial Heifers that will be shown by weight.
9. Substitutions will be permitted and, if made, must be filed with the department superintendent no later than the time animals are checked into the Fair. Substitutions must be owned by the same exhibitor.
10. Premiums – Beef Heifer Division – 1st - \$15; 2nd - \$14; 3rd - \$13; all below - \$12

#### **Market Steer and Market Heifer – RULES AND REGULATIONS**

1. Market Steers and Market Heifers must be owned by January 1, of the current fair year. Market steers and market heifers will be tagged in January, on a date set by the committee. Animals will be identified by breed, weighed, and tagged in Compliance with Maryland Market Livestock Registration system.
2. Any animal that you are planning on showing at the Carroll County 4-H/FFA Fair must be tagged in at the Carroll County Beef & Dairy Cattle tagging.
3. In the event that any animal loses his tag, the Beef Superintendent and 4-H Extension Educator must be notified immediately.
4. Any market steer or market heifer showing crossbred characteristics will be shown in a crossbred class. (All crossbred market beef must be of beef origin.)
5. Any animal with dairy origin will be shown in the dairy steer show.
6. Weight classes will be determined after market steers and market heifers are weighed at the Fair. Refer to the fair schedule for weigh-in date and time. . The 4H/FFA Exhibitor must walk at least one market beef animal (if showing more than one) to the scales. Exceptions must be approved by the Beef Committee.
7. Market beef classes may be shown in this order: Angus, Hereford, Red Angus, Shorthorn, and ALL Other Breeds: (Registered with a Breed Association Paper), Crossbred or in an order determined by the Beef Superintendent and Committee. Each breed will be shown in the order of lightest to the heaviest and classes will be divided according to weight. The Beef Committee will determine the number of classes.
8. When one exhibitor owns two market beef animals in a weight class, another Carroll Co. 4-H or FFA member of the same approximate age and experience may show the extra animal.
9. Exhibitors are limited to exhibiting a maximum combination of **two (2) (NEW FOR 2024)** market steers, market heifers and dairy steers at the Fair. An exhibitor may not win more than two (2) monies in any one class. Extra market beef and dairy may be tagged, with no limit on the number of market steers, market heifers, or dairy steers to be tagged.
10. The show weight will be the official sale weight. There will be no re-weighs. PLEASE NOTE: The Livestock Sale weight requirement for the Carroll County 4-H & FFA Fair is 1200 – 1500 pounds.
11. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified.
12. **The Grand Champion Market Beef MUST SELL** in the Livestock Sale. Consult Livestock Sale Rules for further information.
13. A Breed Division is defined as Four (4) registered animals of that breed. If there is not a minimum of 4 head entered in any breed division, then the animals will be moved to the (AOB) All Other Breeds Division to be shown.
14. Market Heifer Rules and Regulations
  - a. Market Heifers are only eligible to show at the Carroll County 4-H/FFA Fair.
  - b. Market Heifers CANNOT show in the breed show, they will be designated as a Market Heifer at Beef Weigh-In.
  - c. Market Heifers will show during the Market Steer Show.
  - d. Market Heifers will show by weight, a champion will be selected and will be eligible to compete for Grand Champion Market Beef.

- e. Market Heifers must meet the same rate of gain and weight limits as market steers.
- f. Market Heifers must be unbred market heifers to be eligible for show.
- g. Proof that the heifer is open must be verified by a veterinarian within 30 days of the show and submitted to the Beef Committee at the Fair weigh-in.

**15. (NEW FOR 2024)** Market Beef that do not meet the livestock sale requirements will be eligible to exhibit in the Market Exhibition class only and only if it is the exhibitors only Market Beef Project. Market Exhibition classes will be conducted at the start of the Market Beef Show. Animals in the Market Exhibition classes are not eligible to compete in Champion classes and are not eligible for the 4-H Livestock Sale.

16. Premiums – Market Beef Division – 1st - \$15; 2nd - \$14; 3rd - \$13; all below - \$12

### **Bred and Owned Contest – RULES AND REGULATIONS**

1. The Bred and Owned contest is for registered animals only. You must have registration papers that show the exhibitor as the breeder and first owner.
2. The Bred and Owned Market Contest will be held during the Market Show.
3. You will only be allowed to take one (1) project (Steer or Heifer) into the ring during the Bred and Owned Contest.
4. The highest placed Bred and Owned animal in each class will compete for the Champion Bred and Owned of that breed immediately after the selection of the breed reserve champion.
5. The Grand Champion Bred and Owned beef animal will be selected from the breed champions immediately following the selection of the Reserve Grand Champion .
6. This class is created to provide an opportunity for 4-H and FFA members carrying a heifer or cow/calf project to compete among themselves.
  - a. The exhibitor must carry and complete a livestock project record sheet as provided by the 4-H Youth Development Program.
  - b. The market beef animal, which must be designated at the weigh-in/tagging, must be born to a cow owned by the exhibitor, and ownership will be determined by registration papers by breeds.
  - c. General market beef animal class rules must be followed. The Steer or Market Heifer may compete in the regular market division.
7. Exhibitors must maintain control of his/her animal(s) at all times or animal(s) may be disqualified.
8. Premiums – Cattleman's Contest – 1st - \$15; all below \$12

### **Rate of Gain – RULES AND REGULATIONS**

1. Rate of Gain calculations will start at your initial weigh-in at the Beef Identification/Tagging Day and end at the weigh-in at the Carroll Co. 4-H & FFA Fair.
2. Premiums: Blue Award – 3 lb. per day and above; Red Award – 2.5 – 2.9 lb. per day; White Award – 1.7 – 2.49 lb. per day
3. All market steers and heifers are pre-entered.

4. In order to be eligible for the champion rate of gain your animal must meet all sale requirements.
5. Premiums: Champion Rate of Gain - \$250; Blue Award - \$10; Red Award - \$8; White Award - \$6

### **Herdsmanship Award - RULES AND REGULATIONS**

1. Each exhibitor will be observed during the Carroll Co. 4-H & FFA Fair. The animal display area will be evaluated on the basis of:
  - a. Decorations and attractiveness of exhibit
  - b. Cleanliness and care of exhibit
  - c. Cleanliness of aisle and area adjacent to exhibits
  - d. Condition, fitting and presentation of exhibits in barns and show ring
  - e. Personal contribution to the success of the Fair
  - f. Attitude and spirit of cooperation with other exhibitors and Fair Management
  - g. Promptness in show ring

### **Record Book/Portfolio**

1. Recognition will be given to youth submitting a record book or portfolio and evaluated to be the top record book or portfolio in the Beef Cattle project area. Due dates will be announced in the Tribune.
