**Due to proposed Maryland budgetary constraints that are beyond the control of the Carroll County 4-H/FFA Fair Board, Inc., the Board reserves the right to withhold a portion of premium monies, up to and including all of an exhibitors earned premium payment, for the Carroll County 4-H/FFA Fair.**

A 4-H or FFA member must be enrolled in a beginning 4-H project or a soil-science project in order to enter an agriculture commodity exhibit in Agriculture Commodities Department at the Fair.

### Rules and Regulations –

1. Exhibitor should have general knowledge of varieties, maturities, and harvest dates where applicable. The exhibitor must have raised or helped raise and or harvested the products exhibited, especially hay and straw. Questions will be relevant to the specific crop that is being exhibited.
2. Exhibits of hay and straw **must be securely tied four ways**. Exhibit must not be over 6" thick. Exhibit not meeting size standard may be disqualified.
3. If exhibit is taken from a round bale – exhibit **must be compressed and securely tied four ways** – maximum size is 18" x 18" x 6". Exhibits not meeting exhibit size standard may be disqualified.
4. Hay and straw bundles should only be placed in clear bags. **NO Black Bags**. Clear bags will be available to exhibitors from the superintendent if needed.

### MANDATORY ITEM

5. A 3x5 index card must be attached to exhibit with tape or string. The following information should be included on the card.
  - a) Variety
  - b) Was seed certified
  - c) Date of seeding
  - d) Harvest Date
  - e) Intended use

Any exhibitor not providing the index card and information will result in a lower placing. Honey exhibitors are excluded from this rule.

1025	2025	3025	Honey Frames - Frame of capped honey must be supported vertically in a sealed rigid display case with transparent windows for viewing the entire comb.
1026	2026	3026	Block Beeswax - Min. 1 lb. Must be rendered by exhibitor and a product of their hives.

## Section 002—Wool/Fleece Show

### Section Rules & Regulations:

1. Exhibitors may enter a wool fleece from an animal owned by the exhibitor at time of shearing. Fleeces must have been shorn in the year since the last fair. Any fleece off of any sheep that has acceptable length (at least 2 inches) can be entered, including crossbred fleeces. Be sure to enter fleeces in the class that the fleece most closely resembles.
2. Fleece should be rolled properly, flesh side out, in such a way as to allow adequate handling, yet not affect the character or attractiveness. **Each entry must be tagged with: Exhibitor's Name, Address, Breed, Sex, Number of month's growth.**
