Entries must be completed online at www.carrollcountyfair.com. Entry fees need to be paid by credit card only. No late entries will be accepted.

Due to proposed Maryland budgetary constraints that are beyond the control of the Carroll County 4-H/FFA Fair Board, Inc., the Board reserves the right to withhold a portion of premium monies, up to and including all of an exhibitors earned premium payment, for the 2025 4-H/FFA Fair.

- A 4-H or FFA exhibitor must be enrolled in a related project such as hobby or craft or a beginning 4-H project in order to enter the Art Department at the Fair.
- Exhibitors are limited to one entry per class.
- In the event that Artwork is not properly presented and wired correctly for hanging, repairs can be made by the exhibitor in order to bring the artwork up to standards.

Division A - Fine Art and Commercial Art

- 1. Original Artwork derived from unpublished materials (i.e., home photos, landscapes, etc.)
- 2. Interpretation Cartoon figures such as Sponge Bob, Mickey Mouse, Snoopy and other copyrighted images such as Nike, Coke, McDonalds, and or business names and logos, and celebrities (living or deceased) etc. may not be used.
- NO KITS or Paint By Numbers will be accepted.
- 4. All artwork except posters must be presented in a frame wired and ready for hanging.(No pins with wire; no yarn; no fishing line, NO SAW-TOOTH-HANGERS)
- 5. Plastic frames PLEASE make sure that this kind of frame can support the weight of the glass that you put in it.
- 6. USE 12-gauge wire
- 7. Wire should not be visible once hung. (Think of these pieces as how you would want them to look if hung in your house.)
- 8. All artwork will be judged but may not be hung until the presentation is up to correct standards. (See standards in rule #4)
- 9. Artwork cannot exceed 36" x 36". This includes the framing and matting.
- 10.All artwork on paper must be covered. Oil and acrylic paintings on board need to be in a frame no glass. Paintings on a stretched canvas with a wooden stretcher need to be wired (ready to hang). Stretched canvasses may be framed; those without a frame need to have the sides neatly painted. Call the superintendent with any questions and/or for a list of places to get this done.
- 11.Please include a finished piece for the intended design (in one frame, the superintendent requires that you present the original idea/ sketched and finished product.)
- 12. Poster themes can be 4-H related or non-4-H related (if not 4-H, please keep designs clean).
- 13. Poster size should be standard 18" x 24" poster board.
- 14. Poster designs may be vertical or horizontal.
- 15. Only one poster may be entered per exhibitor.

- 16. Poster mediums include pencil, colored pencil, watercolor, acrylic paints, pen and ink, marker, etc.
- 17. Absolutely NO copyrighted cartoon or comic book characters will be accepted. Copyrighted symbols may be used to convey a message (i.e., recycle symbol, 4-H, FFA symbols, etc.)
- 18. Poster exhibits are NOT to be framed.
- 19.On a 3" x 5" index card adhered to the back of the poster; include name, age, full address, and a brief interpretation statement.
- 20.Artwork will be judged using the following criteria if applicable. (Originality, NEATNESS no fingerprints no creases or folds in the paper; Technique; Appropriate use of color or value (value applies to black and white works); Effective Composition
- 21.Poster Art will be judged using the following criteria, if applicable: Theme, simplicity, and originality; Design and lettering pleasing composition, attractive, eye-catching, neat, easily read (near or from a distance),use of color; and Construction materials used, durability, texture, and size
- 22. Premiums Class Champion \$5.; Blue Award \$4.; Red Award \$3.75; White Award \$3.50
