A 4-H or FFA member must be enrolled in a plant-type project or a member of the Carroll County 4-H Horticulture Club or enrolled in Horticulture studies in the Vocational Agriculture program.

Entries must be completed online at www.carrollcountyfair.com. Entry fees need to be paid by credit card only. No late entries will be accepted.

Due to proposed Maryland budgetary constraints that are beyond the control of the Carroll County 4-H/FFA Fair Board, Inc., the Board reserves the right to withhold a portion of premium monies, up to and including all of an exhibitors earned premium payment, for the Carroll County 4-H/FFA Fair.

RULES AND REGULATIONS – Plants and Flowers Department

1. Exhibitors must know prior to coming to enter their exhibit what kind of flowers they are entering in the Plants and Flowers Department. Please identify exhibit on the entry tag. Entries may be disqualified if not identified properly. Consider using permanent markers to identify exhibits.
2. Do not enter flowers in a valuable container. Homegrown blooms should be displayed in a clear, inexpensive container (glass or plastic). Size of bottle should be in proportion to the size of flower blooms (example: baby food jar for small marigolds; largest clear disposable non-refundable bottle for gladiolus). NO paper or foam cups. If a bucket is used, a liner must be within the bucket, so water does not leak.
3. All entry tags are to be placed in a provided plastic plant tag holder. Plant tag holders and water will be available the day of entries on a workstation.
4. Accents of dried or fresh plant material or artificial material may be used in arrangements, corsages, and bud vases regardless of the material required for the class, (Dried Baby's Breath may be used in fresh arrangements and accents such as birds, bows, etc., make a secondary subordinate contribution to the design, and must not be a major focal point of the design).
5. All houseplants are to be exhibited in soil. Containers should not be larger than 12" in diameter. No cans may be used as containers.
6. All exhibitors are responsible for disposal of their exhibits if a plant looks unhealthy or unappealing the superintendent has the authority to remove and will store the container and entry tag in a designated location to be picked up at fair entry pick up. Failure to pick up entries may result in premiums being withheld.
7. Plants must be kept watered by the exhibitor. If assistance required, please see superintendent.
8. Exhibitors may enter only **one** exhibit per class.
9. Exhibits in House Plants classes should be in pots and not with hangers. For example: Classes 35 for Philodendron; if a hanging pot is used – exhibit should be entered in class 41.
10. Houseplants, terrariums, and dish gardens should have been established in the pot or container at least one month.
11. Annuals are flowers that start as a seed and complete its life cycle in one year, no woody plant material. Plants entered that do not follow this guideline will be disqualified.
12. PLEASE CHECK PLANTS CAREFULLY. Any insect or diseased plants will be disqualified and be sent home.
13. Only one kind of plant in the pot – except for dish garden, terrarium, hanging baskets and outdoor display.
14. No foil should be used around the pot. Pot must be scrubbed and clean.

15. Project Record Sheets are HIGHLY encouraged. Project Records are an important aspect to complete any project area a 4-H member has participated in throughout the year. These records showcase what a 4-Her has accomplished in their projects. Bring your plant and flower project record sheet along with your exhibits to the Fair. Plant & Flower exhibits will be accepted without this record sheet. See Section 8 for NEW class. Records sheets will be judged based on completeness to date of entry.
16. Premiums – Class Champion - \$5; Blue Award - \$4.; Red Award - \$3.75; White Award - \$3.50

Section 001- Home Grown Flowers

In the home-grown flower classes where there is more than one stem entered in the individual classes, all flower colors, whether the flower is one color or bicolor, should be identical to one another within that class and the flower be uniform in size. (Example: If you enter a bi-color marigold, all the marigolds within that class should also be bi-color.) Definition – disbudded – should be only one flower at the tip of the stem and all others along the stem should have been removed. All flowers should be labeled with variety name on the entry tag (see #1 above).

Section 002- Houseplants

Exhibit must be planted for a month or more. Container should not be larger than 12" in diameter – no cans permitted as container for plants. Flowerpots must be clean. All houseplants must be identified with variety name on entry tag.

1039	2039	3039	Airplants - an air plant is a tropical American plant that grows on trees as an epiphyte, with long narrow leaves that absorb water and nutrients from the atmosphere. Entries should be displayed how they were grown i.e.. closed or open containers.

Section 003 - Hanging Baskets

Can have more than one plant but must be same variety – read class descriptions.

Section 004 - Outdoor Displays

<u>Jr. (8-10)</u>	<u>Int. (11-13)</u>	<u>Sr. (14-18)</u>	
1051	2051	3051	Outdoor Display – hanging basket or window box – outdoor planter not to be larger than 18" in diameter or box not over 24" long – must have three or more different varieties in display. Example – petunia, geranium, vinca, ivy, impatiens, etc.

Section 005- Terrariums

Terrariums, also called a glass garden, are usually transparent containers (or similar containers) in which plants are grown. Planted one month or more prior to exhibition – check plants -do not mix woodland, tropical, succulent or cactus.

Section 006 – Dish Garden

Should be planted for a month or more prior to exhibition.

1075	2075	3075	Fairy Garden large (greater than 18' by 18') Miniature Garden with at least six different varieties of plants and a choice of structures. Gardens will be judged on plants and design.

Section 007 – Arrangements & Corsages

Refer to Rules and Regulations for Plants and Flowers

Arrangement and Corsage entries will not be returned to the exhibitor. Entries will be given to the 4H Fair representatives (Mr. & Ms. 4H and Fair Ambassadors) for use in parades and pictures.

- Definition – Dry Material – any material that has moisture removed.
- Definition – Treated Material – dried plant material that has been altered, i.e., glycerin zing, painted and/or bleaching.
- Definition – Corsage – ribbon and other accents are permitted.
