- The judging contests at the Fair will serve as one of the scheduled judging practices. The selection of the Carroll County Junior, Intermediate and Senior judging teams will be based on scores averaged from all judging practices.

RULES AND REGULATIONS – Rabbit Judging Contest

- 1. The Written Rabbit Test is one portion of the Rabbit Judging Contest.
- 2. Other segments include a Practicum exam, where participant's judge and place classes of live animals. Other elements of the Practicum exam include oral reasons, equipment identification, breed identification, and identifying disgualifications *in live animals*.
- 3. Contestants in the Rabbit Judging program are encouraged to participate in all parts of the rabbit-judging program. However, participants may take only one portion of the Rabbit Judging program. The final scores will be ranked accordingly.
- 4. Selection of the State 4-H Rabbit Judging Teams will be based on scores on the written rabbit exam, the Practicum exam, information assessed at rabbit judging practices, and attendance at the rabbit-judging practices. (See Tribune for dates and times.)
- 5. Preference for the State 4-H Rabbit Judging Team selection will be given to those 4-H'erswho have attended the judging practices and have participated in many or all portions of the program.
- 6. Clover members are ages 5, 6 and 7 as of January 1st of the current year. For Clovers, the test will provide an opportunity to prepare for the older age group tests. An adult will read the test to Clovers.
- 7. Parents are not permitted to be in the room while the Written Rabbit Test is being given.
