RULES AND REGULATIONS -Livestock Skill-A-Thon

- 1. All contestants must be 4-H or FFA members in good standing. It is recommended that contestant be enrolled in any livestock project butthat is not necessary for participation.
- 2. Participants will answer questions on three or four topics per age division. The questions will cover various aspects of the beef, sheep, orswine industries. Each station should take 5-10 minutes at most.
- 3. Following are examples of topics that could be used in Skill-A-Thon: Breed identification, breed characteristics, specie/herd health, quality assurance, meat-cut identification, external anatomy, internal anatomy, skeletal anatomy, pedigree information, swine ear notching, equipment identification, feed, grain and mineral identification. Reference materials areavailable at the Carroll County Extension Office.
- 4. No parents or spectators are allowed in the Skill-A-Thon rooms. <u>Youth with special needs will be granted parental help if they submit this request with their entry form in advance of the contest.</u> Committee members will read to any contestant who requests that.
- 5. Once a contestant completes the Skill-A-thon, please leave the room and the area immediately. Please DO NOT share information or answers. You want your score to be the best in the contest!
- 6. Participation in a Skill-A-Thon will help you build your communication skills and livestock industry knowledge. THANK YOU FOR PARTICIPATING!
- 7. There are categories for all age groups –Ages as of January 1 of the current year: Clovers (ages 5-7), Junior (ages 8-10), Intermediate (ages 11-13), Senior (ages 14-18). Seniors are invited to help with younger contestants after they complete their own contest.
- 8. Participants may enter one, two, or all three animal categories. The HighIndividual in each 4-H age group (excluding Clovers) must have competed in all three species categories.
- 9. The High Individual in each age group will receive an award or trophy.
