RULES AND REGULATIONS – Small Animal Dress-Up Contest

- 1. Exhibitors must enter the animal they use as their project-entry may not be just any animal or pet.
- 2. Contestants in Classes 1-4 are limited to individual contestants showing one animal only. If you want to show more than one animal, call the superintendent for permission.
- 3. Contestants may enter only one class.
- 4. Judges for each class will select a class winner and a class reserve winner as appropriate.
- 5. All class winners are eligible for overall Grand Champion. 2nd place winners may be eligible for Reserve Grand Champion.
- 6. Each animal will need required health papers as appropriate. Attach a copy to entry form and/or narration.
- 7. Contestants will be judged on originality, workmanship, and overall effect. Sample score sheets are available upon request from the 4-H office.
- 8. Both the animal and the contestant need to be dressed to complement each other and the narration.
