Entries must be completed online at www.carrollcountyfair.com. Entry fees need to be paid by credit card only. No late entries will be accepted.

Due to proposed Maryland budgetary constraints that are beyond the control of the Carroll County 4-H/FFA Fair Board, Inc., the Board reserves the right to withhold a portion of premium monies, up to and including all of an exhibitors earned premium payment, for the Carroll County 4-H/FFA Fair.

- Exhibitors must be enrolled in a swine project or veterinary science project to participate in the Swine Department at the Fair.
- Exhibitors must submit a signed Maryland Show Ring Code of Ethics with entry form. Exhibitors must comply with the Maryland Show Ring Code of Ethics for 4-H and FFA animal exhibits and all General Rules. The Maryland Show Ring code of Ethics has been revised to also include language to address drenching. Quoting the University of Maryland Extension 4-H Code of Animals Science Ethics – Quote- “Drenching at any time after an animal arrives on a fair or other 4-H activity or event premises is prohibited, except when performed by a licensed veterinarian in consultation with fair, event, UME, or 4-H officials for the sole purpose of protecting the health of the animal.”
- **“Feeds and supplements approved for livestock use may be used by exhibitors. If an exhibitor feels their animal is in need of electrolytes due to health concerns of the animal, they may be administered by recommendation of a veterinarian and by the veterinarian, and in the presence of the Department Superintendent, the Livestock Area Superintendent or one of the Livestock Area Assistant Superintendents.”**
- **“When an animal is in need of veterinary care while on the Fair Grounds the Department Superintendent must be notified. When an animal requires veterinary treatment while at the Fair, you may use the veterinarian on the grounds at your cost, call your veterinarian at your cost or remove your animal from the Fair.”**
- **“All exhibitors are expected to follow all 4-H and FFA rules, include the Exhibitor Code of Conduct, Animal Ethics and Welfare, General Fair rules, Livestock Sale Committee rules and Department rules for each specific species being exhibitor by 4-H and FFA exhibitors.”** Youth with market livestock must submit a Livestock Feed Assurance Certificate with their entry form.
- All 4-H and FFA members who exhibit a market livestock project at the 2025 Carroll County 4-H/FFA Fair will be **REQUIRED** to submit a 2025 4-H Project Record for each species exhibited (FFA members must submit a completed FFA Record Book) in order to be eligible to sell a market animal at the 2026 Carroll County 4-H/FFA Livestock Sale.
- If swine exhibit is established as a purebred registered animal, a copy of the registration paper MUST indicate the 4-H ear tag which applies to the animal. The original registration paper must be on hand at the fair in the event the Superintendent requests it.
- **COPIES OF ALL BREED REGISTRATION PAPERS MUST BE MAILED TO VICKI WAGNER, 3600 HAMPSTEAD- MEXICO ROAD, HAMPSTEAD, MD 21074 AND BE RECEIVED BY JULY 20, 2026, ALL PUREBRED MARKET HOGS WITHOUT REGISTRATION PAPER RECEIVED BY JULY 20, 2026 WILL BE MOVED TO THECROSSBREED CLASSES. THE EAR TAG NUMBER IS TO BE WRITTEN ON THE REGISTRATION PAPER FOR THAT HOG. DO NOT MAIL ORIGINALS**
- Your original approved Animal Health paper must be available for review prior to unloading your animal(s) at the Fair. Exhibitors are responsible for filling out the 'self-check' portion on the Livestock Health Paper prior to arriving at the Fair Ground.
- **NOMINATION FOR LIVESTOCK SALE HOG:** Nominations for hogs to be in the Livestock Sale will be taken up to the completion of swine show. The exhibitor wishing to nominate a hog for the sale must be present at time of nomination and personally nominate the hog for sale. **NO EXCEPTIONS!!!**
- All nominated hogs must be processor ready at the time of sale. Hogs being sold must be past a medication withdrawal date should that animal have been treated with medications. Hogs will not be sold prior to a medication withdrawal and held for a later processing date.

- Grading for Livestock Sale – during the market swine show by the judge (Disqualified animals will be noted and members informed at the conclusion of the show.)

RULES AND REGULATIONS

1. The Carroll Co. 4-H & FFA Fair offer classes in purebred breed classes for breeding swine and market classes. Market classes will be divided by weight of the animal at weigh-in. Specific rules and classes for each division follow.
2. Ownership date for market swine exhibit animals is May 1, 2026. Tagging of all market swine with Market Livestock identification tags will be conducted on May 1, 2026. Cost of tags is \$2.00. OWNER must notify the Swine Committee where animal(s) are housed. This will assist in penning assignments at the Fair. The Swine Committee reserves the right to visit all market livestock animals between tagging date and the County Fair.
3. All animals to be shown at the Carroll Co. 4-H & FFA Fair and the Maryland State Fair will be tagged on May 1, 2026, Exhibitors may tag a total of 10 pigs (County Fair – 3 for market show, and 2 for substitutes; State Fair – 5 for market show).
4. Un-castrated male hogs (boars) will not be tagged on May 1, 2026, All male hogs are to be castrated at least 2 weeks prior to tagging and be healed from the castration.
5. Market swine tags, which are placed near the edge of the animal's ear, should be brought to the attention of the Swine Superintendent or Swine Committee member during the initial weigh-in/tagging.
6. All lost tags shall be reported to the Swine Committee as soon as the animal's owner is aware of the missing identification tag. Re-tagging of all lost Maryland 4-H identification ear tags will be handled at the discretion of the Swine Committee upon submission of the original tag to the Extension Office or to the Swine Committee. It is the responsibility of the exhibitor to notify the Swine Committee if a Maryland RF Identification Ear Tag is missing and it is further the exhibitor's responsibility to make arrangements with a veterinarian to replace and retag the hog with a new Maryland RF Identification Ear Tag.
7. Exhibitors will be limited to two entries per class with a total limit of three market show entries. The number of hogs weighed at the Fair scale is equal to the number of hogs enter by the exhibitor. i.e an exhibitor **may not** enter 2 hogs and bring 3 to the scale, then make their choice of which to show.
8. Each exhibitor must provide adequate equipment (cane, whip, hurdle, etc.) for showing.
9. No locks or chains allowed on the pens.
10. Exhibitors are reminded to be courteous at all times – not only to the visiting public, but also to their animals and other exhibitors. Exhibitors will not hold hogs in the wash rack. Hogs should not be in the wash rack sooner than one class before showing.
11. A maximum of four (3) market animals to be shown. The minimum show and sale weight are now aligned at – 240 lbs.; and maximum show weight and sale weight is 295 lbs. THERE WILL BE NO RE-WEIGHS.
12. The Grand Champion Market Swine must sell in the Livestock Sale. READ LIVESTOCK SALE RULES. (Livestock Sale Rules now include a minimum rate of gain of 1.4 lb. per day.)
13. No tack boxes, feed, etc., will be allowed on boards above swine pens. Hanging tack boxes must be hung on the inside of the hog pen for the safety of the public. The Swine Committee will request any tack in the aisles will be moved prior to Swine events.
14. Market Swine pens at the Fair will be maintained in a clean and dry condition. Pens must be cleaned daily before **10:00 a.m. If you are not available to clean your pens, please ask another 4-H friend or family member to clean your pen.** The Swine Committee will request that exhibitor clean pens if needed. Continual neglect of pens may result in forfeiture of premiums.
15. No feeding of exhibits in wash racks is permitted.
16. Acceptable feed rations for animals at the Fair are traditional farm-raised feed grains – either a commercially mixed or home-ground ration.
17. Exhibitors may supply their own bedding.
18. Once an exhibitor's hogs have arrived at the fair, they must have a functioning automatic watering device with adequate water in it, in the pen.
19. Water is the only dressing to be used on the hogs. ABSOLUTELY NO OIL-BASED PRODUCTS, iodine products or any other dressings may be used as it is unhealthy for the hogs and causes problems for the meat-processing facilities.

19. No snares of any type or any form may be used at the fair.
21. Herniated hogs may not be shown.
22. Premiums – Fitting & Showing - \$5 Breeding & Market Classes – 1st - \$12, 2nd - \$11, 3rd - \$10, 4th - \$9, 5th - \$8, 6th - \$7, all below - \$6; Rate of Gain – Blue Award - \$3, Red Award - \$2, White Award- \$1.

Division Number 421 – Breeding Swine – Rules and Regulations

1. All breeding swine must be bona fide property of a single exhibitor and be registered with the appropriate breed association in that **single exhibitor's name only** by June 1 of the current year. The Superintendent or Swine Committee member will check registration papers. Breed Registration numbers are to be entered online at the time of entry.
2. There will be 5 breed classifications – Berks, Durocs, All Other Recognized Breeds – Light Color Hogs- consisting of Chester Whites, Landrace, and Yorkshires, All Other Recognized Breeds – Dark Color Hogs consisting of Hampshires, Herefords, Poland Chinas, Spots and Tamsworth, and Crossbred Breeding hogs. In the case that there are not enough of a certain breed, to represent that breed division, they will be combined into the All Other Recognized Breeds classes. There must be at least 6 hogs owned and exhibited by 3 different exhibitors to qualify a breed to be an individual classification.
3. All breeds of domestic swine that are bred for commercial food production are eligible to show. All breeding swine must be purebreds with pedigrees and ownership verified by registration papers issued by a bona fide breed registry. All hogs shown in the Breed Show must meet their respective breed registration requirements. Purebred animals must meet breed characteristic guidelines as outlined in the National Junior Swine Association.
4. Exhibitors will be limited to no more than two (2) entries per class. However, exhibitors may exhibit 2 entries per breed per class in the Breed Show All Other Breeds classes.
5. Any gilt entered in the 4-H & FFA Fair's Swine Breed Show will not be eligible for market swine classes.
6. The same pen will be assigned for breeding swine exhibits and market swine exhibits for the exhibitor. In the case that the exhibitor does not have market swine, he/she must clean pen before leaving the breed show.
7. Only one animal per exhibitor may be shown in the Breed Producer Class. Animals being shown in the Breed Producer Class must be farrowed from a dam that was owned by the exhibitor prior to gestation. The exhibitor is responsible for making the breeding decision. Hogs farrowed from purchased gilts/sows are not eligible for this class. Hogs shown in the Breed Producer Class are to have Breed Registration papers unless that hog is a crossbred hog. Papers are to show the exhibitor as both the Breeder and the Owner.
8. Boars may not be shown in the Breed Producer Class, gilts only.
9. Any exhibitor showing a boar in the Boar class must take a hog board in the show ring with them. Any exhibitor who does not have a board with them will be disqualified from the class and not be permitted to enter the show ring. The exhibitor may have another person in the ring with them to carry the board. This is for the safety of all exhibitors in the show ring.

Division Number 422 - Fitting and Showing – Rules and Regulations

1. Previous overall fitting and showing champion will show in the Champion of Champions class. Previous Champion of age division may not compete in the same age class. Division Champions will be moved to older age class, provided they are not changing age divisions.
2. In the Swine Department's Fitting and Showing Contest, exhibitors will use their market-hog exhibit unless the exhibitor is showing a breeding animal only. In this case, the Swine Committee must be notified and approval to use breeding gilt will be granted. An exhibitor **may not** keep a Breeding animal to compete in Showmanship if they have a market hog available.
3. All exhibitors will enter in their appropriate 4-H age class.
4. Exhibitors must compete in Fitting & Showing to be eligible to show in the market division.
5. Underweight hogs, under 240 lbs. or over 295 lbs. and/or have a rate of gain less than 1.4 may not be used in Showmanship unless it is the only hog the exhibitor has to show.
6. Any Junior or Intermediate Exhibitor selected as Grand Champion Showman will not be required to exhibit in the Champion Challenge. They will bump up to the next age group instead, until they change age divisions. All Senior Exhibitors selected as Grand Champions will continue to exhibit in Champion Challenge.

Division Number 423 - Individual Market Hogs – Rules and Regulations

For all species, including swine, there will be no exhibition classes. The hogs shown in the Market Show must weigh between 240 lbs.-295 lbs. with a minimum rate of gain of 1.4 lbs. per day. If a hog doesn't meet both requirements, it may not be shown in the Market Show, however the exhibitor may still show the hog in the Swine Showmanship show.

1. Individual market hogs will be divided into classes by weight following the official market show weigh in upon arrival to the fair.
2. NO GILTS shown in the Breeding Swine Show are permitted to be shown in the Market Swine classes.
3. Market animals must be barrows or gilts. Uncastrated males (boars) and/or herniated hogs will not be permitted to be shown.
4. Market swine competition will consist of purebred and crossbred classes. Minimums of ten (10) animals exhibited by 4 different exhibitors make a market breed class eligible. If a breed is represented by 10 or more hogs by 3 different exhibitors, it will be shown as a division. In addition, breeds that are underrepresented by not having at least 10 hogs shown by 4 different exhibitors will be shown as All Other Breeds.
5. Selection of the TOP 5 hogs will be chosen from the Champion and Reserve Champion of all divisions. A Grand Champion, Reserve Grand Champion, followed by the top 3-5 place top hogs will be selected.
6. Purebred animals must meet breed characteristic guidelines as outlined in the National Junior Swine Association or Team Purebred regulations. See www.nationalswine.com or www.teampurebred.com for details. Note that there may be differences for breeding animal and market animal allowable markings. Animals that do not meet breed standards may exhibit in the crossbred division.
7. **For exhibitors showing in the purebred market classes, a copy of the swine exhibit's breed registration papers from the National Swine Registry must indicate the 4-H ear tag number that applies to the registered animal and be given to the Swine Superintendent by July 20, 2026**

DO NOT MAIL ORIGINALS.

Division Number 424 - Swine Producer– Rules and Regulations

1. This division established to provide an opportunity for 4-H and FFA members carrying a swine breeding project to compete among themselves.
2. Animals being shown in the Market Swine Producers Class must be farrowed from a dam that was owned by the exhibitor prior to gestation. The exhibitor is responsible for making the breeding decision. Hogs farrowed from purchased gilts/sows are not eligible for this class. Only one animal per exhibitor may be shown in the Breed Producer Class. Hogs shown in the Breed Producer Class are to have Breed Registration papers unless that hog is a crossbred hog. Papers are to show the exhibitor as both the Breeder and the Owner.
3. Animal may compete in the regular market class if pig meets qualifications.
4. General rules for market classes must be followed. Premiums will be the same.
5. Each exhibitor may compete with only one animal.

Division Number 425 - Swine Rate of Gain – Rules and Regulations

1. Rate of gain determined using weights at tagging and Fair weigh-in on the date as published on the Fair Schedule.
2. Rate of Gain standards – Blue Award – 1.90+ lb. per day; Red Award – 1.7 – 1.89 lb. per day; White Award – 1.4 – 1.69 lb. per day.
3. The market swine exhibit achieving the highest Rate of Gain will be awarded a rosette and trophy.
4. **With the on-line entry system, you must enter this division, entry is not automatic. Premiums will not be paid out if you do not enter Rate of Gain.**

Division Number 426 Swine Project Video Contest

The Swine department will be holding a video contest. The video contest is intended to help enhance the learning and knowledge one gains throughout the swine project and to then convey that gained knowledge in a visual communication tool for the public.

Winners will be selected from two divisions: Individual and Group video. Prizes will be: An overall winner for \$100 dollars. The prizes will be for each division: 1st- \$60; 2nd - \$30; 3rd - \$15. The winners will be announced at the beginning of the Fair and have their videos played throughout the week for the public to view.

Video Rules and Guidelines

1. Entries are to be informative and promotional of the project. The videos should be created in a manner suitable for the public viewership and understanding.
2. There are two divisions: 1st division is **Individual**; 2nd division is **Group**.
 - a. An Individual entry is that of one sole person on the video.
 - b. A Group entry is that of no more than 3 individuals on the video.
 - c. All participants in the Group video must be viewed on camera and contribute vocally in some fashion.
3. Video Entry criteria:
 - a. **Time Limit:** the video entry must be no less than 4 minutes and no more than 10 minutes.
 - b. **The video must have a swine project based topic**, which is clearly and concisely conveyed in the video. (see suggested topics)
 - c. No professional editing allowed.
 - d. No more than 6 PowerPoint slides can be interjected into the video.
 - e. The Parent(s) of the child/ children involved can help with videotaping and with suggestion but must not be heard on the video.
 - f. In order for the video to be accepted all the participants must talk on the video.
 - g. If sources are used to obtain information for the video and directly quoted please give credit to those sources. (end video with credits)
4. The video must be saved in the following formats to be accepted: QuickTime, AVI, or MPEG.
5. Videos should be submitted on a CD, USB memory stick, or a portable external hard drive.
6. An entry form must be submitted with each video.
7. **Entries must be postmarked by July 15, 2026**, and must be mailed to:

Late entries will not be judged.
8. Participants in the video completion must carry a swine project in order to submit a video.
9. Videos will be judged by a three to five judge panel.
 - a. Scoring will be based on a 50 point scale with 10 points given for each of the following categories: Knowledge of topic, creativity/originality, attracts attention, appealing and organization. Each judge shall total their score and rank the entries in numerical order on the basis of their score. (Highest score first, lowest score last.)
 - b. The rankings (not the score) of the three or five judges shall be added to each entry, and the final placing's determined by the lowest composite rankings. Actual scores will only be used to break a tie. In the event the entries are still tied, they will be named co-winners and two awards will be given for that placing and then no award given to the following placing.
10. **All entries must have a parent/guardian signature on the entry form acknowledging that the video and contents are now the property of the swine department and that of the Carroll County 4-H/ FFA Fair; to use as they deem fit in order to promote 4-H, education and the project.**
11. All participants and parents must acknowledge that the videos produced can and most likely will be presented for public viewing.

- Breeding- Natural or Artificial, Farrowing- sow and piglet care,
- Project Pig selection- from a litter or at a sale, Ear notching and Reading Ear notches,
- Pig Care- Housing, feeding, watering, Feed choices- good and bad,
- Swine Breeds- pros and cons, How to show a pig, How to fit a pig, Pig judging,
- Pig cuts of meat, and what else are pigs used for? Transporting pig, Pig health care,
- Why someone should choose a swine project?
- Tour a hog farm and discuss what is involved with raising hogs.
